Please note: We ask for a **deposit** of £25.00 per room at the time of booking to guarantee. 8 weeks prior to the arrival date we require the **balance** payment. If you are booking after the 8 week stage then the full balance will be needed at the time of booking.

We settle the hotel accommodation bill directly with the hotels, leaving you to settle any extras on departure, such as drinks, dinners, etc.

These conditions are our contractual terms with any accommodation booking. They contain important information, so please read them carefully.

deposits and balances. Accommodation reservations,

To make a reservation, a deposit of £25 per room is required after which you will receive confirmation of the booking. This deposit may be non-refundable if the cancellation of the room occurs within 8 weeks of the event subject to the hotel applying contract T&Cs. The payment of the balance is due no later than 8 weeks prior to arrival. (Competitive hotel prices have been negotiated, therefore pre-payment is required prior to your stay.) Non-receipt of the balance on the date due will result in the accommodation being liable for cancellation.

Change of booking by you.

Should you wish to change your accommodation arrangements in any way after we have accepted your booking we will endeavour to meet your wishes to the best of our ability. The first 2 changes will be permitted FOC, thereafter charges will apply and you will be advised in advance before any charges are levied.

Cancellation by you.

All cancellations must be confirmed in writing. If you find it necessary to cancel your booking the following cancellation charges will apply:

Notified 56 or more days before departure - Accommodation only – Loss of deposit - subject to hotel T&Cs

Less than 56 days - As above + any cancellation fee levied by hotel (100% cancellation charge may apply if rooms cancelled within 7 days of arrival)

4. <u>Alteration to confirmed booking by us.</u> It is unlikely that we will have to make any change to your accommodation but we do plan the arrangements many months in advance. Occasionally we need to make changes, which we reserve the right to do at any time. Most of these changes are minor and we advise you at the earliest possible date. If a major change becomes necessary we will advise you as soon as is reasonably possible if there is time before your arrival. When a major change occurs (such as moving you to a different hotel), you will have the choice of either accepting the change of arrangements, or cancelling your accommodation and receiving a full refund.

Event Cancellation

Should the event be cancelled within 8 weeks of the event start date for any reason, we will endeavour to refund or re-allocate any funds to another booking. In some instances we do have to pay non-refundable deposits to hotels and you will be advised on an individual basis if this is applicable to your booking.
